Marion, IL Rotary Club History 1923 to 2003 - 80 years of Service -

The Marion, Illinois International Club No. 1407 was founded April 7, 1923, and completed its Golden year with a big dinner at the Holiday Inn (now Executive Inn) in Marion on April 7, 1973.

The club was formed following a meeting held at the Goodall Hotel on the Public Square (now Tower Square). The hotel later burned and W. T. Grant constructed a store on the location in the 1950's. In 1992, the City of Marion purchased the building after W. T. Grant went bankrupt and converted it into the Marion City Hall.

The formation meeting was presided over by William Baker and Charles Taylor of Harrisburg, IL who were respon-

sible for the formation of a large number of Rotary Clubs in Southern Illinois. Taylor was at that time the District Governor for all of Southern Illinois.

The original meeting was in March 1923 and Marion was finally granted a charter on April 7, 1923. In May 1923, the Rotary Club of Harrisburg came to Marion enmass and formally presented the local club with it's charter.

The first officers were: Edward M. Stotlar, President; Dr. E. E. Woodside, Vice President; Warder Batson, Secretary; Earl Jackson, Treasurer; and Clarence Cox Sergeant at Arms.

The first Board of Directors consisted of E. M. Stotlar, Lawrence H. Bainbridge, Leon Colp, E. E. Woodside, and Warder Batson.

One Charter Member Living in 1973:

The only living charter member of the Marion Rotary Club, Dr. A. E. Prince, attended the 50th anniversary dinner with his Rotary Ann. Dr. Prince was an active pastor of the large Water Tower Baptist Church in St. Louis, MO. He was 86 years of age but still very active. When the Marion Rotary Club was formed, he was the pastor of the Marion First Baptist church and served there from 1921 thru 1927. During the mine riots and Ku Klax Klan troubles in Williamson County during the late 1920's and early 1930's, his church was damaged by a bomb thrown from a passing automobile.

Dr. Prince, along with Dr. W.P. Throgmorton, was one of the 100 Baptists to form the Illinois Baptist State Association and was the only surviving member of that group in 1973.

Dr. Prince started his ministry in Fairfield, IL in 1904 and preached in five states (Illinois, Missouri, Texas, Louisiana, and Hawaii). He was the pastor of the largest Baptist church in New Zealand. In Honolulu he was the principal of the Baptist Academy and founded the Honolulu Christian College where he served as it's first president. Dr. Prince was a president of three colleges and was a Stewardship Evangelist in 36 states of the United States.

Attendance:

The Marion Rotary Club had the most outstanding attendance record of any Rotary Club of over 50 members in the world in 1973. This meant that the members of the Marion Club had either attended their regular club meetings or within a week before or after that meeting have attended a Rotary Club somewhere in the world. Members have made up misses in such far away places at Taipal, China, France, Italy, England, South America, Canada and Mexico.

Attendance had been made possible by uniform good programs every week, by good meals furnished by the women of the First United Methodist Church, by starting and stopping meetings on time and by an esprit-de-corps of the total membership built up over many years.

When Jack Kuykendall was President of the Club in 1925 he started a drive to force attendance. Attendance is not forced now, but it is considered the proper and right thing to do and is a part of the obligations of being a good member of the Marion Club. The fact that for over 2,000 meetings of the club, attendance was 99 percent was positive evidence how valuable Marion felt attendance was to the members of the club.

Past Presidents William (Bill) Giles and Ira Nelson were so anxious to maintain their 100 per cent record on different occasions, that when they were patients at the Marion Memorial Hospital they were brought to the meeting in an ambulance on a stretcher by James R. Wilson, who operated the Wilson Funeral Home and ambulance service in Marion at those times. Wilson eventually became the County Coroner and served in that elected position for many years.

Marion Rotary Club attendance record was mentioned in the June 1938 issue of the national Rotarian Magazine.

In 1929, Marion engaged in an attendance contest with the Herrin Rotary Club and Marion won, although there was only one miss during an entire year between clubs.

The longest period of consecutive 100 per cent attendance was for 21 months from December 1940 until August 1942.

Although a miss due to illness is never mentioned, despite the fact that it does count against the club record. Some of those who unintentionally, unthinkingly or accidentally have missed a meeting were forcefully reminded of their negligence at the next meeting they attended. When the District Superintendent of a local public utility company, and later a past President of the club missed, every member wore a black arm band in mourning of the miss; when a local monument manufacturer missed, he was given a toy pistol so he could shoot himself if his memory didn't improve, but when the next miss did occur, the monument builder presented the erring member with a miniature monument with the legend "Marion Rotary Attendance Record - Gone But Not Forgotten" and when the head of a chain of drug stores returned from an Eastern vacation trip, various members explained to him (with data taken from the International Rotary Directory, available to any member) that Rotary Clubs had been meeting every day that he spent in several of the eastern cities he visited.

In recent years, Marion ran a close race for attendance with the Johnston City Rotary club, which because of the proximity to Marion, also enjoys a large make-up attendance from the Marion club.

Club Secretaries

A complete list of secretaries is not available, but the first secretary was the late Warder Batson. Others included Earl Witter, A. B. Aikman, Charles Creighton, Oldham Paisley, Harold Pangborn, John H. Cossing, Hugh Smith, LaRue Swinney, Dr. Joe McAlpin, Albert Kaaeser,

Laurence Bouas and Wilson Giles. LaRue Swinney, who served as secretary for 16 years, held that office for the longest period of time.

Officers of Other Clubs

At one time the Marion Rotary Board was composed of John Clayton, who had previously been President of the Johnston City club; James Wilson, who had previously been President of the Zeigler club, and "Bud" Logan, who had previously been president of the Christopher club. Both Clayton and Wilson served terms as President of the Marion club.

Meeting Places

The club when formed met at the First Baptist Church, but left there, according to reports at the time, because Dr. W. P. Throgmorton of that church objected to the members smoking during the meeting.

The meetings have, however, been held in the basement of the First United Methodist Church for most of the eighty years of the club's existence.

At times, meetings have been held at other places, such as in the hangar at the old Marion Airport (east of town); at the US Federal Prison (80 members and guests attended that meeting); at the home of Harry L. Crisp; the Country Club home of "14" Norman, as well as a fish fry at the Lake of Egypt, with 60 present in 1968.

On another occasion, aq caterer prepared the meal, which was served at a meeting held at the Giles Armature and Electric Works. After the Dinner, Past District Governor Bill Giles and Past President Harold Chase initiated the members into the intricacies of armature winding.

At the time of the regular high school Rotary Awards day, the meeting is always held in the high school cafeteria and then adjourned to the school auditorium for presentation of keys and pins.

One meeting was held in the cafeteria of John A. Logan College at Cartersville.

In 1929, a "ladies night" was held at the Marion Golf Club, which is now the home of "Mutt" and Ida Fluck on West Main street on the south side of the intersection with Halfway Road. One Hundred Seventy Five Rotarians and wives were present.

In 1928, the club enjoyed a venison dinner, with the meat furnished by Dr. H. D. Norris, who had killed the deer in the west and brought it to Marion on the hood of his automobile.

In 1924, the Marion club journeyed to Harrisburg for a joint meeting and on numerous occasions, Marion has joined with other clubs in the area for inter-city meetings, the most recent one being held in Marion at the Holiday Inn (Executive Inn) on February 27, 1973 at which time District Governor Kermit Beasley inducted new members from all parts of Southern Illinois into Rotary.

Joint meetings have been held on several occasions with the Lions Club and the Kiwanis Club of Marion. One of these was when James V. Bennett, Director of the U. S. Bureau of Prisons of the Federal Justice Department was the guest of Rotary. Bennett was introduced by Myrl Alexander of Carbondale, who later took over the position of Prison Bureau Director. Bennett and Alexander are the two men most responsible for selection of Marion for the present Federal Prison south of Marion.

Among the unusual meetings that the Marion club has held, was one arranged by Louis Nielsen on October 10, 1957, when he was the local telephone company manager. At that time, International Vice President Albert P. Banthan spoke to the Marion club, live, over the telephone from Schnectedy, NY. Later, J. W. Travelstead, then commercial manager of the telephone com-

pany, presented a "Closed Circuit" television program and still later there was a demonstration of the laser beam.

When Guy Hitt was the District Governor in 1963, he arranged an inter-city meeting in Marion with Phil Lovejoy, Secretary-General of Rotary International as the speaker.

Out-Of-Town Speakers

We have just told of the visit of the first Secretary-General of Rotary International to Marion, but among the many others from a distance who spoke were: Howard Salisbury, Vice President of Air-Reduction Corporation of New York; Arnold Maremont, Chicago Industrialist; Elmer Rhoden of Kansas City, President of the Fox-Midwest Theatre chain; Nathaniel Leverone, Chairman of Automatic Canteen Company; and in 1973, President David R. Derge of Southern Illinois University who spoke to a joint meeting, arranged by the Rotary Club, of all Marion civic clubs.

First District Conference

Although not a district conference, the first large meeting of area Rotary Clubs was held at The Hanger at the old Marion Airport which was

then east of Marion on Old Route 13 (East Main Street) and is now the home of Fabick Machinery Company. This meeting was held in March, 1932, when Dr. Harvey A. Felts was the Marion Club president and the speaker was Canon Elliott of Leeds, England. The first District Conference to be held in Marion was in May 1934, when Oscar Schafale was the club president.

The meetings were held at the hangar at the Old Marion Airport, which has since been abandoned, and which has since become the home of the Fabick Machinery Company. Registrations were at the Hotel State (on the Tower Square - West side) but the meetings and final program was at the hangar, where the Greek owners of the Gem Cafe served 1,365 Rotarians and guests. There were 622 Rotarians registered from 34 different clubs. Dr. H. D. Norris was the banquet chairman. The principal speakers were Claybrook Cottingham of England, who represented Rotary International and Branch Rickey of the St. Louis Cardinals baseball team.

Harry R. Rodd was the Mayor of Marion at that time. Prizes were given for perfect attendance and the club from Gilman had 100 percent of its members present. O'Fallon was next with a total of 4,704 miles traveled and others included: Metropolis 4,312 miles and Zeigler 880 miles. Gilman, O'Fallon, Zeigler and Metropolis all had 100 per cent of their membership present for the meeting as well as the Marion club.

Second District Conference

The second District Conference was held in Marion on May 10 and 11, 1950 at which time Kenneth Avis was the club president and James Frick was the conference chairman. The programs were held at the Orpheum Theatre and at the Marion High School new gymnasium (on West Main Street which is part of the Marion Junior High school in 2003) where the Governor's Ball was held Saturday evening. The principal speaker was Roy D. Hickman of Birmingham, AL who became the International President, having been elected at the last International convention held in Houston, TX.

Despite a rain that dampened some of the floats there was a big parade in the afternoon, with a reviewing stand on East Main Street in front of what is now the Washington School. Nathaniel Leverone, chairman of the Automatic Cantee Company was the conference speaker.

Third District Conference

The third district conference to be held in Marion was April 24-25, 1964 when the meeting was held at the Travelodge Motel during the time that James Sanders was District Governor.

Doan Farr of Clinton, Oklahoma was the official representative of Rotary International at this conference and spoke at the Saturday evening dinner in the Egyptian Sands room of the motel. Farr was a past president of his own club and a past District Governor of Rotary International as well as a national council member of the Boy Scouts of America and an honorary master farmer of the Future Farmers of America. He was chairman of the 1962 Los Angeles International Rotary Convention. John Clayton was the president of the Marion club at that time and Joseph DiPietro was not only the incoming president, but was conference chairman. Leo Cox was the vice-chairman.

At that time Marion had the unusual distinction of every member on its board of directors had served as the club president at some time or the other. James Wilson, the vice president, had previously been president of the Zeigler Rotary Club; John Clayton had served a term as president of the Johnston City Club; Clarence Logan had been president of the Christopher Club and Dr. Joseph McAlpin was the immediate past president of the Marion Club.

The program for the Rotary Anns at that conference included a bus tour of the area, including the Federal Prison, Crab Orchard Lake, Giant City State Park and Southern Illinois University. A luncheon and style show was given for the ladies at the University Center of Southern Illinois University in Carbondale.

The program was concluded on Saturday evening with a dance for Rotarians and their Rotary Anns at the Travelodge Motel and Conference Center.

Inter-City Rotary Meeting

On February 27, 1973, Southern Illinois Rotary Clubs in this area had an inter-city meeting at the Holiday Inn (now Executive Inn) in Marion with a large attendance from all over the district. At that meeting District Governor Kermit Beasley inducted new Rotarians into Rotary from all over the 651st (now 6510) district. Ray Monsaltvage of Dayton, Ohio was the principal speaker at that meeting.

Teenarian-Interact Club

The Marion Rotary Club has already been active in working with the young people of Marion, especially thru the Interact (formerly Teenarian) Club. In 1933 Past President Clarence Cox, formed the first Teenarian club and it has been active ever since. In this club, each high school boy is matched with a Rotarian as his sponsor and the sponsor is suppose to indoctrinate the youth on his classification.

Similar clubs flourished at Johnston City and in Herrin and a so called "International convention" was held in Johnston City on March 29, 1951, with "delegates" from all three cities. Jerry Williams was president of the Marion club at tha time, with LaVern Crow of Johnston City and Lowell Hall of Herrin as their club presidents.

The name was suggested by Dean Charles Thompson of the University of Illinois and the District Governor at that time and a letter in the files of the Marion club shows that it was approved by Rotary International.

Besides working with the Marion Rotarians, the Tennarians aided in financial help to flood refuges in Holland. In 1933 when Ernest Parks, Jr. was president of their club, they gave the noon program at the Marion club.

During the year, the Interact members are guests of their Rotary sponsor at least once in the year and Rotarians give programs for their club at the high school. Nearly 2,000 boys have been members of what is now the Interact Club, which is a world-wide organization and holds its meetings wherever the International convention is being held, such as Lausanne, Switzerland, in 1973.

For many years, between Christmas and New Years, the Rotary had as its guests all of the boys and girls in Marion who were attending college at that time. Marion has also sent one or more delegates to a Youth world conference held in Carbondale at SIU each year.

Herrin, IL Conference

In Mary, 1946, the District Conference was held in Herrin, at thiwhc time Roy V. Jordan was the District Governor and Dolph Bradshaw was president of their club, with Fred Miller as vice-president. Chester Tobin, a former member of the Changhai, China Rotary Club, was the dinner speaker on the opening night. At the afternoon program on the second day, Desmond Hosmer of the Monsanto Chemical Company spoke on "Chemistry Unlocks the Door of Southern Illinois Resources." He was followed by an address by

Tom Hood, past District Director of Rotary Internationa. Others who took part included Rev. Harvey Zuern of Marion, and District Governor Louie E. Lewis, "Gib" Lentz, and George Crichton who was the program chairman. Charles Perry of Chicago, past president of the Chicago Rotary Club spoke on "The Justification of Rotary." There was a large parade of school bands from all over Southern Illinois and contains numerous floats.

Other Activities

Several "Institutes of International Understanding" were held in Marion, with outstanding speakers of national stature to enlighten the members and friends on world problems.

The Marion club joined with the Marion Lions Club in promoting a radio station for Marion. The three principal civic clubs, Rotary, Lions, and Kiwanis, have all worked together for everything from new schools to the enlargement of the airport, all which are of great benefit to the community.

In April 1963, the Marion Rotarians sold special newspapers on the streets here to raise funds for the construction of a non-demominational chapel at Southern Illinois University in Carbondale. Newspaper sales netted \$365. In 1957, the Marion club members joined Rotarians from he area to build a structure at Campe SO-BO-GI (Southern Illinois Boys and Girls) on the banks of Little Grassy Lake. In 1924, Rotary members helped take a census of boys in the city of Marion between the ages of 6 and 18, and the same year Rotarians helped purchase the uniforms for the grade school band. The Marion club in 1938 exchanged greetings with a Rotary Club in San Carlos, Nuble, Chili. Our club is Number 1407 and theirs is Number 4407.

Working for Scouting

The June 1927 Rotarian Magazine tells how Ed Stotlar and Jack Kuykendall of the Marion Rotary Club started the Boy Scout work in Marion that resulted in the formation of the Franklin-Williamson County Council, which was later expanded to its present size and name of Egyptian Council, covering all of Southern Illinois. Among the boys atneding the first Boy Scout Reservation in Goreville in 1924 was John Burnett Cline, now a member of the Marion club as well as Jean Burkhart, a former member, and Dr. Norman Albert of Johnston City.

Helping the Handicapped

One of the most successful activities of the Marion club in its early life was a school and clinic for handicapped children. It was the first such clinic in the State of Illinois outside of Cook County. A. B. McLaren and Dr. E. E. Woodside were the principal workers, but they had the co-operation of all of the members. At Christmas time, the committee brought all the handicapped children to our meeting so that Santa Claus could bring them presents from club members. Charles Hamilton was the club president when the school was started.

Herrin Rotary Club

The Herrin Rotary Club, which was formed in 1922, a year before the Marion club, celebrated its 50th anniversary in 1972. The Herrin club dedicated its Golden Anniversary booklet to Jo V. Walker, a charter member of their club and still an active member. Walker, one of whose mem's clothing stores in in Marion, is well know here. His son, Jo M. Walker, is a member of the County Board of Commissioners.

Although born in Carterville, he attended high school in Marion. He is a fine example of the Rotary motto of "Service Above Self" and he is credited with working for all the good things that have come to Southern Illinois, including our lakes, the Boy Scout Council, the county airport, Southern Illinois University and Southern Illinois Incorporated, and the area Chamber of Commerce. He served in the U. S. Navy during World War I and played in the Great Lakes Naval Band directed by John Phillip Sousa.

Two Misses for Presidency

Twice in the history of the Marion Rotary Club, men slated to become the club presidents have left the city before they could take office. Richard "Dick" Broderick was to become the president the year he was promoted from Division Manager of the Central Illinois Public Service Company (now AmerenCIPS) to a higher position in their main office in Springfield, IL. Rev. Carl Hearn, pastor of the Marion Methodist Church, was tranferred to a new pulpit, just before he was to take office as president. He has since retired from active ministry and is now associate pastor with the Methodist Church in Mount Vernon, IL.

Good Music

The Marion club has been blessed with members who could tickle the piano keys, including Bill Forker, a mail carrier, Rev. Carl Hearn, and Rev. Max Martin. The club has also been equally blessed with song leaders, including Albert Kaeser, Harold Chase, and Lynn Zech. At the recent inter-city meeting in Marion, Zech had charge of the singing.



High School Rotary Awards

In 1936, Mark Woodley, who was the club president at the time, started the annual distribution of "Rotary Awards" to worthy scholars at the Marion High School. Selection was made by vote of the faculty on a fifty-fifty basis of scholarship and school activities. A gold key is given to the outstanding boy or girl in each class for first place and a silver key for second place, plus pins for the next eight in each class. In the case of a tie vote, then both point winners received the same award.

If the same boy or girl receives the gold key each year in school (previously it required four years, but with the institution of a three-year high school, only three gold keys are required. The Marion High School has since been restored back to a four-year school) a diamond is placed in the key in the final year.

Those who have received diamond keys are: James Felts, James Sanders, Betty Boatright, David Jackson, Jack Riddle, Carol Reichert, John Kent, Romelle and Dale Harris, Mike Dare and James Pape.

Originally the presentations were made at a night meeting of the club with the winners as guests of the club. Now the awards are given at the high school and are made in the presence of the student body.

Miss Ann Morgan, who received a gold key in 1957, later became the National President of the American Legion Auxiliary's Girl's State in Washington, D. C.

Student Loans

Through an assessment against all members several years ago, a student loan fund was created which has helped about fifty boys or girls attending college. In almost all cases the money has been returned, with interest, after they finished their college work.

Marion is over a 300 per cent contributor to the Rotary Fellowship Fund which makes it possible for exceptionally well qualified boys and girls to study in a foreign country. We have also contributed to a fund providing scholarships at Southern Illinois University for students from "south of the border." Many of these students have spoken to the Marion club. This fund was started in 1946 when Dean Schwartz of Carbondale was the district governor.

In 1969 under President L. C. Cavaness, the club pledged \$100 a year scholarship for John A. Logan College, which was just being established in this county at that time.

International Conventions

Marion Rotarians have attended International conventions through out the world. It has been impossible to obtain a complete list of the local club delegates, but those noted were: Past District Governor Bill Giles in Mexico City, Atlantic City and Philadelphia; Past District Governor James Sanders in New York City; Nice, France; Sydney, Australia; Miami, FL; Dallas, TX; St. Louis, MO; Toronto, Canada; and Los Angeles, CA. (In most instances, they took their five children with them); Joe Shelton in Los Angeles, CA; LaRue Swinney and President Ray Schmidt in Miami, FL; Lawrence Wohlwent and President James Frick in Mexico City, Mexico; and Oldham Paisley in New York, NY twice, Denver, CO; Sydney, Australia; and Houston, TX. Sanders and Oldham Paisley attended the convention in Lausanne, Switzerland in 1973.

Nelson Ash attended the convention in Toronto, Canada and President Joe DiPietro attended the convention in Atlanta City, NJ when Illinois Governor Adlai Stevenson was the speaker.

Rotary Publication

As far back as any of the present members can recall, the Marion Rotary Club has kept in

touch with its activities through their own publication known as "The Marion Rotascope."

In its early years, Sam Casey, editor and owner of the Marion Evening Post was the publisher and it was printed every week from type set on the linotype by Mr. Casey. In later years, among the others who have acted as editors included Lawrence Sanders, W. O. Paisley, Oldham Paisley, Richard Darby, and Milt Witt.

The "Rotascope" is a one page mimeographed sheet, always listing the coming programs as well as the birthdays of Rotarians, their Rotary Annns and their wedding anniversaries. On many occasions, jokes that have appeared in an issue of the Rotascope have appeared in the International Rotarian Magazine.

Rotary Banners

Marion has a fine display of Rotary banners from various parts of the United States and foreign countries, including several from international conventions. These banners signify that someone from the Marion club has attended that club, or someone from that club has been a guest at the Marion club.

50th Anniversary Dinner

In commemoration of Marion's 50th year as a Rotary Club, a banquet was held at the Holiday Inn (now Executive Inn) in Marion. The program was in charge of President Jesse Hill and the officers of the club, including Raymond Allen, Clay Hunter, Laurence Bouas, Richard Darby, Wilson Giles and Duane Mayberry.

Dr. Joe McAlpin was general chairman for the observance. His assistant chairmen included: Paul Morris on arrangements; Bill Bowlby on program; Richard Darby on publicity; Harold Chase on finance; Oldham Paisley on club history; Clay Hunter on Interact and Lynn Zech and Max Martin in charge of music. Dr. Nathan Ivey served as Master of Ceremonies.

Charles McCullers, a Past District Governor of Rotary International of Garner, NC was the speaker. McCullers, who has been active also in the American Legion, the Masonic Lodge, the Y.M.C.A., the Salvation Army, and the Methodist Church, gave a very instructive as well as humorous address.

This history of the Marion Rotary Club was prepared from the files and morgue of the Marion Daily Republican by Oldham Paisley (who was a member of the Marion Rotary Club since 1932) and with the cooperation of many members, including LaRue Swinney and Richard Darby.

(The history of the Marion Rotary Club from 1923 to 1973 was obtained from a booklet prepared by the club in celebration of it's 50th anniversary on April 7, 1973. New Club Started in Marion

Marion, IL Rotary Club #1407 By-Laws

(Adopted June 5, 1975)

Article I Election of Directors and Officers

Section 1 - Two months prior to the meeting for election of officers, the president will appoint a three-member nominating committee. The committee will prepare a list of candidates for the elective offices of the club, giving due consideration to the normal succession through the offices, the qualifications of the candidates, and the willingness of the candidates to serve the club. At a regular meeting one month prior to the meeting for the election of officers, the presiding officer will ask for nominations by members of the club for president, vice-president, secretary, treasurer, and two members of the board of directors. The nominations will be presented by the nominating committee and by members from the floor. The nominations duly made shall be placed on a ballot in alphabetical order under each office and shall be voted for at the annual meeting. The candidates for president, vice-president, secretary, treasurer, and the two candidates for director receiving a majority of the votes shall be declared elected to their respective offices.

Section 2 - The officers and directors, so elected, together with the immediate past president, shall constitute the board of directors. Within one week after their election, the board of directors-elect shall meet and elect some member of the club to act as sergeant-at-arms.

Section 3 - A vacancy in the board of directors or any office shall be filled by action of the remaining members of the board.

Section 4 - A vacancy in the position of any officers-elect or director-elect shall be filled by action of the remaining members of the board of directors-elect.

Article II Board of Directors

Section 1 - The governing body of this club shall be the board of directors, consisting of seven (7) members of this club, namely, two (2) directors elected in accordance with Article I, Section 1, of these by-laws, the president, vice-president, secretary, treasurer, and the immediate past president.

Article III Duties of Officers

Section 1 - President. It shall be the duty of the president to preside at meetings of the club and board and to perform such other duties as ordinarily pertain to this office.

Section 2 - Vice President. It shall be the duty of the vice-president to preside at meetings of the club and board in the absence of the president and to perform such other duties as ordinarily pertain to this office.

Section 3 - Secretary. It shall be the duty of the secretary to keep the records of membership, record the attendance at meetings, send out notices of meetings of the club, board, and committees, record and preserve the minutes of such meetings, make the required reports to Rotary International, including the semi-annual reports of membership, which shall be made to the general secretary of Rotary International on January 1st and July 1st of each year, the report of changes in membership, which shall be made to the general secretary of Rotary International, the monthly report of attendance at the club meetings which shall be made to the district governor immediately following the last meeting of the month, collect and remit to Rotary International subscriptions to *The Rotarian*, and perform such other duties as usually pertain to his office.

Section 4 - Treasurer. It shall be the duty of the treasurer to have custody of all funds, accounting for same to the club annually and at any other time upon demand by the board and to perform such other duties as pertain to his office. Upon his retirement from office, he shall turn over to his successor or to the president all funds, books of accounts or any other club property in his possession.

Section 5 - Sergeant-At-Arms. The duties of the sergeant-at-arms shall be such as are usually prescribed for his office and such other duties as may be prescribed by the president or the board.

Article IV Meetings

Section 1 - Annual Meeting. An annual meeting of this club shall be held on the second regular meeting day in December in each year at which time the election of officers and directors to serve for the ensuing year shall take place. (Amended July 22, 1976).

Section 2 - The regular weekly meetings of this club shall be held on Thursday at 12:00 noon. Due notice of any changes in or canceling of the regular meeting shall be given to all members of the club.

Section 3 - One-third of the membership shall constitute a quorum at the annual and regular meetings of this club.

Section 4 - Meetings of the board shall be called by the president, whenever deemed necessary, or upon request of two members of the board, due notice having been given.

Section 5 - A majority of the board members shall constitute a quorum of the board.

Article V Fees and Dues

Section 1 - The admission fee shall be \$5.00 and the scholarship fund fee shall be \$10.00, for a total of \$15.00 to be paid before the applicant can qualify as a member.

Section 2 - The membership dues shall be \$180.00 per annum, payable semi-annually on the first day of July and of January with the un-

derstanding that two dollars and fifty cents (\$2.50) shall be applied to each member's subscription to the Rotarian magazine. (Amended June 30, 1977).

Article VI Method of Voting

The business of this club shall be transacted by *viva voce* vote except the election of officers and directors which shall be by ballot.

Article VII Committees

Section 1 - (a) The president shall, subject to the approval of the board, appoint the following standing committees:

1. Community Service Committee
2. International Service Committee
3. Vocational Service Committee

(b) The president shall, subject to the approval of the board, also appoint such committees on particular phases of community service, international service, and vocational service as he may deem necessary.

(c) The community service committee, the international service committee, and the vocational service committee shall each consist of a chairman, who shall be named by the president from the membership of the board, and of not less than two other members.

(d) The president shall, subject to the approval of the board, appoint the following committees on particular phases of club service:

1. Attendance Committee
2. Fellowship Committee
3. Magazine Committee
4. Membership Committee
5. Membership Development Committee
6. Program Committee
7. Public Relations Committee

appoint one member each year to the following committees:

1. Classifications Committee
2. Rotary Information Committee

and appoint any other committees that he may

deem necessary for the internal administration of club affairs.

(e) Where feasible and practicable in the appointment of club committees, there should be provision for continuity of membership, either by appointing one or more members for a second term or by appointing one or more members to a two-year term. No member shall be eligible to serve on the same committee for more than two successive years, except as otherwise specifically provided in these by-laws.

(f) The classifications and Rotary information committees shall each consist of three members, one member of each committee to be appointed each year for a term of three years. The first appointments made under this provision shall be as follows: One member for a term of one year; one member for a term of two years; one member for a term of three years.

(g) The magazine committee shall, wherever feasible, include the editor of the club publication and a local newspaper or advertising member of the club.

(h) The president shall also appoint one member of the board who shall be responsible for all club service activities and who shall supervise and coordinate the work of all committees appointed on particular phases of club service.

(i) The president shall be ex-officio a member of all committees and, as such, shall have the privileges of membership thereon.

(j) Each committee shall transact such business as is delegated to it in the by-laws and such additional business as may be referred to it by the president or the board. Except where special authority is given by the board, such committees shall not take action until a report has been made to the board and approved by the board.

Article VIII

Duties of Committees

Section 1 - Community Service Committee. This committee shall devise and carry into effect plans which will guide and assist the members of this club in discharging their responsibilities in their community relationships. The Chairman of this committee shall be responsible for the community service activities of the club and shall supervise and coordinate the work of

any committees what may be appointed on particular phases of community service.

Section 2 - International Service Committee. This committee shall devise and carry into effect plans which will guide and assist the members of this club in discharging their responsibilities in matters relating to international service. The chairman of this committee shall be responsible for the international service activities of the club and shall supervise and coordinate the work of any committees that may be appointed on particular phases of international service.

Section 3 - Vocational Service Committee. This committee shall devise and carry into effect plans which will guide and assist the members of this club in discharging their responsibilities in their vocational relationships and in improving the general standards of practice in their respective vocations. The chairman of this committee shall be responsible for the vocational service activities of the club and shall supervise and coordinate the work of any committees that may be appointed on particular phases of vocational service.

Section 4 - (a) Attendance Committee. This committee shall devise means for encouraging attendance at all Rotary meetings - including attendance at district conferences, intercity meetings, regional conferences, and international conventions by all club members. This committee shall especially encourage attendance at regular meetings of this club and attendance at regular meetings of other clubs when unable to attend meetings of this club; keep all members informed on attendance requirements; promote better incentives for good attendance; and seek to ascertain and remove the conditions that contribute to unsatisfactory attendance.

(b) Classifications Committee. This committee shall as early as possible, but no later than 31 August of each year, make a classification survey of the community; shall compile from the survey a roster of filled and unfilled classifications, using the guide to classifications; shall review, where necessary, existing classifications represented in the club; and shall counsel with the board on all classification problems.

(c) Fellowship Activities Committee. This committee shall promote acquaintance and friendship among the members, promote partici-

pation by members in organized Rotary recreational and social activities, and do such work in pursuance of the general object of the club as may be assigned by the president or the board.

(d) Magazine Committee. This committee shall stimulate reader interest in The Rotarian and/or Revista Rotaria; sponsor a magazine week; arrange for brief monthly reviews of the magazine on regular club programs; encourage the use of the magazine in the induction of new members; provide a copy of the magazine for non-Rotarian speakers; secure international service and other special subscriptions for libraries, hospitals, schools, and other reading rooms; send news items and photographs to the editor of the magazine and in other ways to make the magazine of service to the club members and non-Rotarians.

(e) Membership Committee. This committee shall consider all proposals for membership from the personal side and shall thoroughly investigate the character, business, social, and community standing and general eligibility of all persons proposed for membership and shall report their decisions on all applications to the board.

(f) Membership Development Committee. This committee shall review continually the club roster of filled and unfilled classifications and shall take positive action to initiate and present to the board the names of suitable persons to fill the open classifications.

(g) Program Committee. This committee shall prepare and arrange the programs for the regular and special meetings of the club.

(h) Public Relations Committee. This committee shall devise and carry into effect plans (1) to give the public generally information about Rotary, its history, object and scope; and (2) to secure proper publicity for the club.

(i) Rotary Information Committee. This committee shall devise and carry into effect plans (1) to give prospective members information about the privileges and responsibilities of membership in a Rotary Club, (2) to give the members, especially the new members, adequate understanding of the privileges and responsibilities of members, (3) to give the members information about Rotary, its history, object, scope, activities, and (4) to give the members information as to developments in the administrative operation of Rotary International.

Article IX Leave of Absence

Upon written application to the board, setting forth good and sufficient cause, leave of absence may be granted excusing a member from attending the meetings of the club for a specified length of time

(Note: Such leave of absence does operate to prevent a forfeiture of membership; it does not operate to give the club credit for the member's attendance. Unless he attends a regular meeting of some other club, the excused member must be recorded as absent except that absence authorized under the provisions of Article VIII, Section 5(c) or 5(d) of the stand club constitution is not computed in the attendance record of the club.)

Article X Finances

Section 1 - The treasurer shall deposit all funds of the club in some bank to be named by the board.

Section 2 - All bills shall be paid only by checks signed by the treasurer upon vouchers signed by any two officers. A thorough audit by a certified public accountant or other qualified person shall be made once each year of all the club's financial transactions.

Section 3 - Officers having charge or control of funds shall give bond as may be required by the board for the safe custody of the funds of the club, cost of bond to be borne by the club.

Section 4 - The fiscal year of this club shall extend from July 1st to June 30th, and for the collection of members' dues shall be divided into two semi-annual periods extending from July 1st to December 31st, and from January 1st to June 30th. The payment of per capita dues and magazine subscriptions to Rotary international shall be made on July 1st and January 1st of each year on the basis of the membership of the club on those dates. (Note: Magazine subscriptions for members joining during a semi-annual period are payable upon invoice from the secretariat.)

Section 5 - At the beginning of each fiscal year, the board shall prepare or cause to be prepared a budget of estimated income and estimated expenditures for the year, which, having been agreed to by the board, shall stand as the limit of

expenditures for the respective purposes unless otherwise ordered by action of the board.

Article XI

Method of Electing Members

Section 1 - Active Members (Including additional active members).

(1) From time to time the board shall review the list of filled and unfilled classifications as prepared by the classification committee and decide which, if any, of the unfilled classifications should be considered as open for proposals and shall advise the membership as to which classifications have been opened for proposal.

(2) The name of a prospective active member to fill an open classification, having been proposed by the membership development committee or by an active, senior active, or past service member in good standing, shall be submitted first to the board, through the secretary, on a standard form known as the proposal card.

(3) The board shall then refer it to the classifications committee which committee shall consider the eligibility of such proposed member from the standpoint of classification and declare the proposed classification proper or improper and shall return the proposal card, together with this information, to the board. The board shall then, if the classification is proper, refer the proposal card to the membership committee.

(4) After making due investigation of the character, business, social standing, and general eligibility of the person proposed for membership, the membership committee shall then proceed to vote and if not to ex- one negative vote is cast by the members of this committee, the name of the proposed member shall be considered eligible and so recommended to the board. The membership committee shall then report to the board the action it has taken thereon.

(5) The board shall then review the action of the classification committee and sustain or reject their decisions or refer it back to the classifications committee and the membership committee for further consideration and action. If the classifications and membership committees have reported adversely upon the name of the newly proposed member and the board has sustained the action, the proposer shall be so notified by the secretary.

(6) If the classifications and membership committees have reported favorable upon the name of the proposed member and the board has sustained the action, the secretary shall notify the proposer.

(7) The proposer, accompanied by a member or members of the Rotary information committee of the club, shall fully inform the proposed member of the privileges and responsibilities of membership in a Rotary club, and shall secure the oral or written permission of the proposed member to publish his name to the membership of the club.

(8) After permission to do so has been secured from the proposed new member the secretary shall notify each member of the club by a written or printed communication, giving the name of the proposed candidate, the firm represented, and the classification under which he/she is proposed for membership.

(9) A ten-day period shall then be allowed during which any member objecting to the election of the proposed member shall notify the board in writing, stating reasons for his objection.

(10) If no objection is received in such period, the proposed member shall be considered qualified for membership. If any objections have been filed, the board shall consider the same at any regular or special meeting of the board and proceed to ballot on the proposed member. If not to exceed two (2) negative votes are cast by the members of the board in attendance at this regular or special meeting of the board, the proposed member shall be considered qualified for membership.

(11) The secretary shall then notify the proposed and the proposed member of his qualifications for membership and invite the proposed member to apply for membership in the club.

(12) When the proposed member has filled in, signed, and returned to the secretary the regular form of application, indicating his understanding and acceptance of the responsibilities of membership, together with his remittance for the admission fee as provided for in Active V, he/she shall be considered duly elected to membership.

(13) After having received the completed application and the remittance for the admission fee, the secretary shall issue to the newly elected member a Rotary membership identification card.

(14) The secretary shall then fill in a new member report form for the newly elected member and forward the completed form to the general secretary of Rotary International. In the event the proposed member is rejected, the proposer shall be so notified by the secretary.

Section 2 - Senior Active, Past Service, and Honorary Members. The name of a proposed candidate for any one of these three kinds of membership shall be submitted to the board of directors in writing and the election shall be in the same form and manner as prescribed for the election of an active member provided, however, that such proposal may be considered at any regular or special meeting of the board and that the board may at its discretion waive any of the steps as set forth in Section 1 of this Article and proceed to ballot on the proposed member. If not to exceed two (2) negative votes are cast by the members of the board in attendance at the regular or special meeting, the proposed member shall be considered duly elected, provided, however, that any active member of past service member of this club who qualifies for senior active membership as set forth in the constitution of this club shall automatically become a senior active member of this club, no application for or election to such senior active membership being required.

Section 3 - Re-Election of Former Additional Active Member.

(1) The application of a former additional active member of this club who was elected a ssuch member under Article III, Section 2(a) of the by-laws of Rotary International and whose membership was terminated as provided in Article VIII, Section 2(b)(1) of the constitution of this club shall be considered promptly by the board and in advance of any other application or proposal under the same classification or another classification.

(2) When the membership of an additional active member elected under the provisions of Article V, Section 5(b) of the constitution of this club has ceased as a result of the classification becoming vacant, then when the classification is again filled, he may (without prejudice to the right of the holder of the classification to propose an additional active member under Article V, Section 5(a) of the constitution) then be re-elected.

(3) At its discretion the board may refer any application to the classifications and membership committees and the board may provide for a

ten-day period during which any member objecting to the election of any proposed member shall notify the board in writing, stating reasons for his objection. At any regular or special meeting, the board shall proceed to ballot on the applicant taking into account, where applicable, reports from the classifications and membership committees and any objections filed. If not to exceed two (2) negative votes are cast by members of the board in attendance at the regular or special meeting, the former additional active member or members shall be considered duly elected to membership and shall be so notified by the secretary. In the event any application is rejected, the applicant shall be so notified by the secretary.



Constitution

of the

Rotary Club of Marion, IL

Charter #1407 (3323)

Article I Name

The name of this organization shall be **Rotary Club of Marion, Illinois**.

Article II Territorial Limits

Section 1 - The territorial limits of this club are as follows: The business area of Marion, IL.

Article III Object

The object of Rotary is to encourage and foster the ideal of service as a basis of worthy enterprise and, in particular, to encourage and foster:

First. The development of acquaintance as an opportunity for service;

Second. High ethical standards in business and professions; the recognition of the worthiness of all useful occupations; and the dignifying by each Rotarian of his occupation as an opportunity to service society;

Third. The application of the ideal of service by every Rotarian to his personal, business and community life;

Fourth. The advancement of international understanding, good will, and peace through a world fellowship of business and professional men united in the ideal of service.

Article IV Meetings

Section 1 - This club shall meet regularly once each week on the day and the time provided in the by-laws, provided that in an emergency, or for good cause, the board of directors of the club, may change the regular meeting of any week to a

different day of the same week or to a different hour of the regular day, or to a different place, or cancel the regular meeting of any week when it falls on a legal holiday, or because of the death of the club president or an epidemic or a disaster affecting the the entire community.

Section 2 - An annual meeting for the election of officers of this club shall be held not later than the thirty first day of March in each year as provided in the by-laws of this club.

Article V Membership

Section 1 - Kinds. There are four kinds of membership, namely: *active*, *senior active*, *past service*, and *honorary*.

Section 2 - Active Membership. Each active member shall be an adult male person of good character and good business or professional reputation.

(a) engaged as proprietor, partner, corporate officer, or manager of any worthy and recognized business or profession; or

(b) holding an important position in an executive capacity with discretionary authority in any worthy and recognized business or profession; or

(c) acting as the local agent or branch representative of any worthy and recognized business or profession, having charge of such agency or branch in an executive capacity; and

Personally and actively engaged, within the territorial limits of this club, in the business or profession in which he/she is classified in the club and having his/her place of business located therein.

Section 3 - Classifications. (a) Each active member of this club shall be classified in accor-

dance with his/her business or profession.

(b) The classification of each active member shall be that which covers the principal and recognized activity of the firm, company or institution with which he/she is connected, or if he/she be independently engaged in a business or profession, his/her classification shall be that which covers his principal and recognized business or professional activity.

(c) How Corrected. The board, in its discretion, may correct or adjust the classification of any member, whose membership has not terminated, if the circumstances warrant such action. Due notice of such proposed correction or adjustment shall be given to the member and he/she shall be allowed a hearing thereon.

Section 4 - Limitations. The active membership shall consist of but one person from each classification of business or profession, excepting the newspaper and religion classifications, and excepting the provision for additional active members as provided in Sections 5 and 6 of this Article.

Section 5 - Additional Active Member. (a) Any active member of this club may propose for and the club may elect to active membership one additional person from the concern or establishment with which the proposer is connected, whose classification shall be the same as that of the proposer. The qualifications of such additional member shall be those required for active membership. An additional active member is in all respects an active member except that the membership of an additional active member elected under the foregoing provisions of this section shall automatically terminate with the termination of the active membership of the active member who proposed him/her.

(b) The club may, subject to the approval of the holder of the classification, elect to additional active membership in the club any former active member of a Rotary club whose place of business whereat he/she is actively engaged is within the territorial limits of the club and who is otherwise qualified for membership provided

(1) That there shall, in no case, be more than one additional active member elected under this paragraph of the Section in respect of any one classification, and

(2) That any member so elected shall have terminated membership of his former club only because he/she ceased to be actively engaged within the territorial limits of that club in the classification of business or profession under which he was classified in that club, and

(3) That an additional active member elected under this paragraph of this Section shall cease to be a member when the classification becomes vacant, provided that when the classification is again filled, he may (without prejudice to the right of the holder of the classification to propose an additional active member under paragraph (1) of this Section) then be re-elected.

Section 6 - Religion and Newspaper Classifications. Representatives of more than one denomination and of more than one newspaper published within the territorial limits of this club may be eligible to active membership under the same classifications, provided that they otherwise possess the qualifications for active membership.

Section 7 - Public Office Holder. Persons elected or appointed to public office for a specified time only shall not be eligible to active membership in this club under the classification of such office. This shall not apply to persons holding a position or office in schools, colleges, or other institutions of learning.

Section 8 - Local Preference. No man/woman engaged as a local agent or branch representative of an outside concern shall be eligible to active membership when a suitable prospective member may be available whose principal place of business is within the territorial limits of this club.

Section 9 - Senior Active Membership. (a) Any active member of this club

(1) Who now is and has been an active member of this or other clubs for a total of fifteen or more years, or

(2) Who is of the age of sixty or more after having been an active member of one or more clubs for a total of ten or more years, or

(3) Who is a present or a past officer of Rotary International, or

Any past service member of this club who had been an active member of this club and who, at the time he ceased to be an active member of this club, had the qualifications for senior active membership as hereinbefore set forth, may at his/her option, become a senior active member of this club by notifying the secretary in writing.

(b) Any active member of a club who is of the age of sixty-five or more after having been an active member of one or more clubs for a total of five or more years shall automatically become a senior active member.

(c) This club may, at its option, elect to senior active membership in this club any former active member of any club, who was eligible to senior active membership, at the time he/she ceased to be an active member of a club, provided such former member resides within the territorial limits of this club or within the surrounding area.

(d) A senior active member shall have all the rights, privileges and responsibilities of an active member except that

(1) He/she shall not be considered as representing a classification; and

(2) He/she shall not have the right to propose an additional active member

This club may admit to membership a qualified person in the classification of business or profession in which such senior active member may be engaged.

Section 10 - Past Service Membership. A former active member of a club, whose active membership was terminated because of his/her retirement from active business or professional life, may be elected a past service member in this club provided he/she has been an active member in one or more clubs for five or more years. Such former member may be elected to past service membership at the time of, or at any time after, the termination of his active membership, provided he has all the other qualifications of a past service member. If his retirement from business or professional life occurs after he has ceased to be a member of a Rotary club, he is not eligible to past service membership. He/she must reside and continue to reside within the territorial limits of this club or within the surrounding area, unless he/she has been an active member in this club in which event he/she may reside and con-

tinue to reside in the locality of his/her residence at the time he/she ceased to be an active member in this club.

(b) A past service member shall have the rights, privileges and responsibilities of an active member except that

(1) He/she shall not be considered as representing a classification,

(2) He/she may not exercise the option to become a senior active member (except as provided in Section 9 (a) of this Article),

(3) He/she does not have the right to propose an additional active member.

Section 11 - Honorary Membership. (a) A person who resides within or who has resided within the territorial limits of the club and who has distinguished himself/herself by meritorious service in the furtherance of Rotary ideals there or elsewhere may be elected to honorary membership in the club.

(b) Honorary members shall be exempt from payment of admission fees and dues, shall have no vote and shall not be eligible to hold any office in the club; shall have no interest in any property of the club; shall not be considered as representing a classification, but shall be entitled to attend all meetings and enjoy all other privileges of the club. No honorary member of this club is entitled to any rights or privileges in any other club.

Article VI Officers and Directors

Section 1 - The governing body of this club shall be a board of directors to be constituted as the by-laws of the club may provide.

Section 2 - Except as herein otherwise specifically provided the decision of the board in all club matters shall be final, subject only to an appeal to the club. The board shall have general control over all officers and committees and may, for good cause, declare any office vacant. It shall constitute a board of appeal from the rulings of all officers and actions of all committees. Appeal may be taken from any decision of the board to the club. On such appeal the decision appealed from shall be reversed only by a two-thirds vote of the members present, at a regular meeting

specified by the board, a quorum being present, notice of such appeal having been given by the secretary to all members of the club at least five days previous to such meeting.

Section 3 - The officers of this club shall be a president, one or more vice-presidents, all of whom shall be members of the board, and a secretary, a treasurer, and a sergeant-at-arms, any or all of whom may or may not be members of the of the board as the by-laws of the club shall provide.

Section 4 - Each officer shall take office on the first day of July following his/her election and shall hold office for the period of his/her election or until his/her successor has been elected and qualified. Each officer and each director shall be an active (including additional active), senior active, or a past service member in good standing of this club.

Article VII Admission Fees and Dutes

Section 1 - Every active, senior active, and past service member of this club shall pay as an admission fee and as annual dues such sums as may be prescribed in the by-laws of this club except that a senior active or past service member who has held active membership in this club shall not be required to pay a second admission fee.

Article VIII Duration of Membership

Section 1 - Period. Membership shall continue during the existence of the club unless terminated as hereinafter provided.

***Section 2 - How Terminated. (a) Active membership** shall automatically terminate if, and when, an active member ceases to be personally and actively engaged within the territorial limits of the club in the classification of business or profession under which he/she is classified in the club or ceases to have his/her place of business therein, or his/her connection with his/her business establishment is severed.

(b) (1) The membership of an additional active member elected under the provisions of Article V, Section 5(a) of this constitution shall automatically terminate with the termination of the membership of the active member who proposed him/her, or in the event such active member be-

comes a senior active member of this club. If such additional active member is promptly re-elected to active membership in this club, he/she shall not be required to pay a second admission fee.

(2) **An additional active member** elected under Article V, Section 5(b) shall cease to be a member when the classification becomes vacant provided that when the classification is again filled he may, (without prejudice to the right of the holder of the classification to propose an additional active member under Article V, Section 5(a) of this constitution) then be re-elected.

(c) Senior active membership shall automatically terminate if, and when, an elected senior active member ceases to reside within the territorial limits of this club or within the surrounding area. This provision does not apply to one who has become a senior active member automatically or at his/her own option.

(d) Past service membership shall automatically terminate if, and when, a past service member re-enters active business or professional life, or if, and when, he/she ceases to reside within the territorial limits of this club or within the surrounding area. The second of these provisions shall not apply to a past service member who has been an active member of this club. Such member may reside and continue to reside in the locality of his/her residence at the time he/she ceased to be an active member of this club.

(e) Honorary membership shall automatically terminate on the thirtieth day of June next after the date of election. However, the board in its discretion may, by resolution, from year to year continue such honorary membership for the ensuing year. Such honorary membership may be continued by the board although the person so elected has ceased to reside within the territorial limits of the club.

Section 3 - How to Rejoin. When the membership of an active member has terminated as provided in the foregoing Section 2, such person may make new application for membership, under the same classification or another classification. Such application by an additional active member elected under the provision of Article V, Section 5(a) of this constitution shall be considered, before any other, for membership under the classification in which he/she applies. If elected to membership, he/she shall not be required to pay a second admission fee.

Section 4 - Termination - Non-Payment of Dues. Any member failing to pay his/her dues within thirty (30) days after the prescribed time shall be notified in writing by the secretary at his/her last known address. If the dues are not paid on or before ten (10) days from the date of notification said membership shall automatically terminate. Such former member, at the discretion of the board, may be reinstated to membership upon his/her petition, and upon the payment of all his/her indebtedness to the club, provided that no former member can be reinstated to active membership if his/her former classification has been filled.

Section 5 - Termination - Non-Attendance. (a) The membership of any active, senior active, or past service member except as provided in this Article, who is absent from four consecutive regular weekly meetings of this club shall automatically terminate, unless such absence is made up as hereinafter provided, or he/she is excused by the board for good and sufficient reason. Any member absent from a regular meeting of this club may make up such absence by attendance at a regular meeting of any other Rotary club or a provisional Rotary Club on any of the six days immediately preceding the day of absence, on the day of the absence itself, or on any of the six days immediately following the day of absence and be given full credit for attendance in this club, provided notice of such attendance is given to this club by the secretary of the club visited or the member may make his own report.

In the event an active, senior active, or past service member of this club presents himself/herself at the regular time and place of meeting of any other club for the purpose of attending the meeting of such club, and such club has omitted, postponed, or changed the time or place of its meeting for said week, then such member shall be credited with attendance by this club for the week for which he would be entitled to credit had such meeting been held at the regular time and place, provided notice of such circumstances is given to this club by the secretary of the club visited or the member may make his own report.

Any active, senior active, or past service member of this club who is serving as an officer of Rotary International, or a committee person of Rotary International, or as a special representative of the district governor, or who is in the employ of Rotary International absent from a regular meeting of this club on Rotary business shall be credited with attendance at such meeting missed while on such business, provided notice

of such circumstances is given to this club by the member.

Any active, senior active, or past service member of this club absent from a regular meeting of this club while traveling with reasonable directness to or from a convention of Rotary International, an international assembly, a Rotary institute for past and present officers of Rotary International, a Rotary international conference, a Rotary International committee meeting, a Rotary district conference, a district Rotary information institute, a Rotary district assembly, or a regularly announced intercity meeting of Rotary clubs shall be credited with attendance at such regular meeting of this club, provided notice of such circumstances is given to this club by the member.

Any active, senior active, or past service member of this club absent from a regular meeting of this club who attends a convention of Rotary International, an international assembly, a Rotary institute for past and present officers of Rotary International, a Rotary international conference, a Rotary International committee meeting, a Rotary district conference, a district Rotary information institute, a Rotary district assembly, or a regularly announced intercity meeting of Rotary clubs, on any of the six days immediately preceding the day of absence, on the day of absence itself, or on any of the six days immediately following the day of absence shall be credited with attendance at such regular meeting of this club, provided notice of such attendance is given to this club by the member.

(b) The membership of any active, senior active, or past service member, except as hereinafter provided, whose percentage of attendance is less than sixty per cent during the first or second six months of the club's fiscal year shall automatically terminate, unless he is excused by the board of good and sufficient reason.

(c) Any senior active or past service member who, because of protracted ill health or impairment, is physically unable to comply with the provisions of this section may, during the period of its continuance, upon application to the board, be excused from complying with attendance requirements and his/her absence shall not be computed in the attendance record of the club.

(d) Any senior active or past service member who has been a member of one or more Rotary clubs for in the aggregate twenty years or more, and has reached the age of sixty-five years, may notify the secretary in writing of his/her desire

to be excused from complying with attendance requirements. If approved by the board such member's attendance or absence shall not be computed in the attendance record of the club.

Section 6 - Termination for Other Causes.

(a) The membership of any member who shall cease to have the qualifications for membership in this club may be terminated by the board by the votes of not less than two-thirds of the members thereof, at a meeting called for that purpose.

(b) The membership of any member may be terminated by the board, for a reason which the board may deem to be sufficient, by the votes of not less than two-thirds of the members thereof, at a meeting called for that purpose.

(c) In either case (a) or (b) the member shall be given at least ten days' notice in writing of such pending action and an opportunity to submit to the board a written answer. He/she shall also have the privilege of appearing before the board to state his/her case. Service of such notice shall be made by personal delivery or by registered letter to his last known address.

(d) In case of a decision to terminate membership the secretary shall, within seven days after the date of the board's decision, notify the member in writing of the decision of the board. Such member may, within fourteen days after the date of such notice, give written notice to the secretary of his/her intention either to appeal to the club or to arbitrate as provided in Article XII of this constitution. In the event he/she appeals, the board shall set a date for the hearing of the appeal at a regular meeting of the club, to be held within twenty-one days after the receipt of such written notice of appeal. At least five days' notice of such club meeting and its special business shall be given in writing to every member of the club, and only members of the club shall be permitted to be present when such appeal is considered at such meeting.

(e) When the board has terminated the membership of an active member as provided for in this Section, the club shall not elect a new member under his former classification until the time for hearing the appeal, if any, has expired and the club's decision or the decision of the arbitrators has been announced.

(f) The action of the board shall be final if no appeal to the club is taken and no arbitration is

requested. If an appeal is taken, the action of the club shall be final.

Section 7 - Resignation. The resignation of any member from this club shall be in writing (addressed to the president or secretary) and shall be accepted by the board, provided that all indebtedness of said member to the club has been paid.

Section 8 - Property Interest - Forfeiture of. Any person whose membership in this club has been terminated in any manner shall forfeit all interest in any funds or other property belonging to the club.

**Article IX
Public Affairs**

Section 1 - The general welfare of the community is of concern to the members of this club and the merits of any public question involving such welfare may be fairly and intelligently studied and discussed before a club meeting for the enlightenment of its members in forming their individual opinion. However, this club shall not express an opinion on any pending controversial public measure.

Section 2 - This club shall not endorse or recommend any candidate for public office and shall not discuss at any club meeting the merits or demerits of any such candidate.

**Article X
Official Publication**

Section 1 - By acceptance of active, senior active, or past service membership in this club such member voluntarily becomes a subscriber to the monthly publication of Rotary International. His subscription shall be handled in six-month periods and shall continue as long as he is a member of the club and to the end of any six-month period during which he may cease to be a member of the club.

Section 2 - The amount of the subscription shall be collected by the club from each member, semi-annually in advance. The secretary shall enter such subscriptions and amounts so collected in a special subscription account and remit to Rotary International.

Section 3 - The board of directors of Rotary International may prescribe this standard club

constitution without this Article for the use of clubs outside of the United States of America and Canada.

Article XI Acceptance of Object and Compliance with Constitution and By-Laws

A member by payment of his admission fee and dues thereby accepts the principles of Rotary as expressed in its object and submits himself to and agrees to comply with and be bound by the constitution and by-laws of this club, and on these conditions alone is entitled to the privileges of the club. No member shall be absolved from the observance of the constitution and by-laws on the plea that he has not received a copy of them.

***Article XII Arbitration**

Should any dispute arise between any member or members, or a former member of members, and the club, or any officer or the board of this club, relative to membership or to any alleged breach of the constitution or by-laws, or the expulsion of any member from the club, or on any account whatsoever which cannot be satisfactorily settled under the procedure already provided for such purpose, the matters in difference shall be settled by arbitration. Each party shall appoint an arbitrator and the arbitrators shall appoint an umpire. Only members of a Rotary club may be appointed as umpire or as arbitrators. The decision arrived at by the arbitrators, or, in the event of their disagreement, by the umpire, shall be final and binding on all parties.

Article XIII By-Laws

Section 1 - This club shall adopt by-laws not inconsistent with the constitution and by-laws of Rotary International (and the rules of procedure for an area administration where established) and with this constitution, embodying additional provisions for the government of this club. Such by-laws may be amended from time to time as therein provided.

The by-laws of Rotary International, adopted at the convention in Los Angeles, California, U.S.A., June 6 1922, require that each Rotary club thereafter organized shall adopt this prescribed standard constitution.

Article XIV Amendments

Section 1 - Time. This constitution, except in any emergency as provided for in the by-laws of Rotary International, and except as provided in Section 4 of this Article, may be amended only at a convention of Rotary International, held in an even-numbered year, by a majority vote of the electors present and voting at the time such amendments are submitted to the convention.

Section 2 - Who May Propose. Amendments to this constitution, except as provided in Section 4 of this Article, may be proposed only by a club, by a district conference, by the general council or the conference of Rotary International in Great Britain and Ireland, by the council on legislation, or by the board of directors of Rotary International.

***Section 3 - Procedure.** Any proposal to amend this constitution shall be delivered to the general secretary of Rotary International not later than the first day of August in the Rotary year in which the council on legislation is to meet.


The general secretary of Rotary International shall mail a copy thereof to the secretary of each club by the first day of November in the Rotary year in which the council on legislation and the convention are to consider legislation.

The general secretary of Rotary International shall transmit directly to the council all duly proposed amendments.

The council shall consider each such duly proposed amendment and any proffered amendment thereof and report to the convention its recommendation for action thereon.

***Section 4 - Article I (Name) and Article II (Territorial Limits)** of this constitution may be amended at any regular meeting of this club by the affirmative vote of a majority of members present and voting, provided that notice of such proposed amendment shall have been mailed to each member at least ten (10) days before such meeting, and provided further, that such amendment shall be submitted to the board of directors of Rotary International for its approval and shall become effective only when so approved.
